You have indicated an interest in becoming a CASA volunteer. We conduct multiple trainings a year. Our trainings are a crucial part of preparing you for your volunteer position. We have a few different options for training to best fit your schedule. We offer group training when possible and a self-guided training is available when not possible. If you are interested, please fill out the enclosed application and mail it to the address above or send it to our email. The need is great and we always have cases waiting for an advocate.

All of our CASA volunteers go through a screening process. Therefore, we want you to know that any information found may affect your acceptance into the CASA program. The initial screening process begins with the standard application form, which must be thoroughly completed. The next step is an informal interview. This will allow us to meet in person and answer any questions you may have about the program. The final step is a check of your references in addition to a criminal records check, and a Child Abuse Registry check. We will continue the screening process throughout the training classes. All information received throughout the screening process will be kept completely confidential and only used for CASA purposes. Thank you for taking the time to consider becoming an advocate.

I understand I will not be accepted as a CASA advocate if I have been convicted of, or have charges pending, for a felony or misdemeanor involving a sex offense, child abuse or neglect, or related acts that would pose a risk to children in the CASA program or the credibility of the CASA program. Other charges that would not pose a risk to children will be considered on a case-by-case basis.

To the best of my knowledge, I do not have a conviction or prior history of adult or child abuse/neglect or maltreatment. Neither have I been convicted of a crime involving moral turpitude. I understand that my name will also be checked against local, state, and national databases for criminal activity.
